14TH MAY 2019, DEPART 16:30

The provincial government persuaded settlers to change the name of the town to Vancouver, after Captain George Vancouver, who sailed the region's waters in 1792. Canada's third-largest city, Vancouver is a cosmopolitan place with a European feel and a personality all its own. It's a community with a rich ethnic mix - including the second-largest Chinatown in North America - and stunningly beautiful parks.

KETCHIKAN

16TH MAY 2019, ARRIVE 08:00 - DEPART 17:00

Ketchikan is known as Alaska's "First City" because it's the first major community travelers come to as they journey north. Located on an island, Ketchikan began life as an Indian fishing camp. The name Ketchikan comes from a Tlingit phrase that means "eagle with spread-out wings," a reference to a waterfall near town.

Day 5 (Vancouver To Jasper)

Cruise arrives back Vancouver - Transfer by bus and depart from Vancouver and drive through the farming communities of the Fraser Valley. Ascend into the Coastal Mountains and follow the Coquihalla Highway to Kamloops, in the arid interior of British Columbia. After lunch, retrace the route of the famous Overlanders along the North Thompson River to reach your hotel in Jasper. Overnight in Jasper.

Day 6 (Jasper To Banff)

Your day starts with a scenic hike through Maligne Canyon before heading South. Then, travel along the world-famous Icefields Parkway to take in some of nature's most spectacular mountain scenery. Have your camera ready for possible wildlife sightings! Highlights include Athabasca Falls, Peyto Lake, and the Columbia Icefield.

Ride the “Ice Explorer”* on Athabasca Glacier or visit the Glacier Skywalk*. Overnight in Banff.

Day 7 (Sightseeing In Banff National Park)

Enjoy a full day of sightseeing in Banff National Park. Start your morning with a leisurely hike in Johnston Canyon and stroll along the shores of picturesque Lake Louise and Moraine Lake. In the afternoon, visit the world famous Banff Springs Hotel and Bow Falls. With your free time in Banff, you may also choose from optional activities such as soaking in the natural spa at the Upper Hot Springs* or taking a gondola ride to the top of Sulphur Mountain*. Overnight in Lake Louise.

Day 8 (Lake Louise To Vancouver)

This morning, enjoy a drive through Rogers Pass, the highest part of the route to the Rockies. On your scenic return journey through Yoho National Park, catch a glimpse of an engineering marvel: the Spiral Tunnels. Arrive in downtown Vancouver in the evening. Overnight Vancouver

Day 9 (Depart Vancouver)

Catch a taxi to the airport for your flights home to Australia.

DEPOSIT

FINAL PAYMENT

Payment in full must be made no less than 90 days before travel, unless required earlier by any supplier.

PRICES

All prices for our tours are advised in Australian Dollars (\$AUD). They are based on airfares, schedules and tariffs at the time of printing. Destination International Holidays reserves the right to vary the cost of the tour, taxes and airline prices if necessary by reason of currency fluctuation, cost increase, or airfare increase.

AMENDMENT FEES
