Celebrity Apex Overview

Celebrity Apex is the second of Celebrity's Edge Class ships. She will debut in April 2020. Her inaugural sailing is an 8-night Spain and Portugal cruise over the 2020 Easter break. Then follows a Norwegian Fjords cruise, and an exciting new pairing of 10-night Capital Cities Cruises to iconic capitals like Oslo, Copenhagen, Amsterdam, and Paris. Completing her Southampton mini-season is a 10-night Iberian Peninsula cruise to Rome. Celebrity Apex will then sail the Mediterranean mostly between Barcelona and Civitavecchia (for Rome) from 7 to 10 nights. In October she crosses the Atlantic to Florida (14 nights). Until the end of 2019 Celebrity Apex offers 7-night cruise from Fort Lauderdale to the Western and Eastern Caribbean. The ship will be recognised for its cantilevered side platform – Magic Carpet – that lowers and raises to four levels for fast embarkation and tendering, for a specialty restaurant, as an al fresco expansion of lido deck, and “Dinner on the Edge” for 90 guests. Embarkation uses facial recognition. The Celebrity smart phone app executes all your requests – including opening your cabin door.

Accommodation

The ship offers a full range of cabins: Interior (2 classes, 9%), Ocean view (3 classes, 10%), with Verandas (6 classes) and Suites (10 classes) making up 81% of staterooms. The largest single class comprises 512 Edge Staterooms with Infinite Verandas. Across the range are wheelchair accessible cabins (all non-suite), staterooms for 3 or 4 guests, and 178 connecting rooms. All staterooms have king-sized beds, apart from the 16 Edge Singles with queen beds. With touch of a button select open-air access, personalised lighting, shades, temperature and room service. The 146 Sky Suites are arranged with beds facing the ocean. Accommodations also include all the other stateroom categories of the Solstice Class ships: Royal, Family, AquaClass, Concierge and Sunset Veranda.

Food and Dining

Celebrity Apex offers 29 dining options, including seven specialty restaurants. There are four main dining rooms (American, French, Italian, and seafood) with traditional two seatings or ‘any time’ dining. Luminae restaurant is forward in the Retreat, and exclusive to all suite guests. Blu dining is for AquaClass guests. There are seven specialty dining venues, with cover charge and by reservation. Menus include American, French, steak, seafood. Specialty dining is complimentary to higher class guests. Room service is assured 24 hours a day from a limited menu of sandwiches, pizzas, salads and desserts.

Entertainment

During the day The Rooftop Garden will host yoga and various games and activities. At night it morphs to offer live music and movie-and-meal pairing – “A Taste of Film”. Celebrity’s main showlounge typically presents song and dance revues, along with singers, comedians and musical acts. Also, expect street performers and live music ship-wide. During the day entertainment choices will range from games, art auctions, bingo, wine samplings and dance lessons, to educational presentations. Theme nights are often held in one of the lounges. For a quiet time withdraw to the card room or 24-hour library. Play casino-style games on your Apple or Android smartphone while on board. Celebrity iLounge is the shipboard computer enrichment and Internet hub from Apple.

The Australian GST does not apply to international travel. Any service fees, courier, cancellation and amendment fees are subject to GST. You will be charged GST where applicable.

DEPOSIT

A deposit is required to confirm your booking (varies depending on package booked). Receipt of deposit will be taken as an understanding by Destination International Holidays that the customer has checked their confirmed travel arrangements and has read and agreed to the terms and conditions.

FINAL PAYMENT

Payment in full must be made no less than 120 days before travel, unless required earlier by any supplier.

PRICES

All prices for our tours are advised in Australian Dollars (\$AUD). They are based on airfares, schedules and tariffs at the time of printing. Destination International Holidays reserves the right to vary the cost of the tour, taxes and airline prices if necessary by reason of currency fluctuation, cost increase, or airfare increase. All prices are subject to confirmation from local tour operators. Once full payment has been received by Destination International no surcharges in respect to currency fluctuations will be applied.

ITINERARY CHANGES

Destination International Holidays reserves the right to amend the itinerary for reasons such as service requirements, road or weather conditions or unforeseen circumstances. Where a change is

of a significant nature, it will be advised to our customers in writing. Destination International Holidays reserves the right to substitute hotels, lodges, inns and camps with properties of similar standard

AMENDMENT FEES

Any deviation to packages advertised or quotes will incur a fee of \$150 per person.

Should you need to alter your confirmed reservations, there will be an automatic fee charged of \$150 per amendment or transaction, plus any new arrangements made. Additionally, there may be cancellation fees levied by the tour operator or fees may be applicable where arrangements have been pre-purchased.

In addition, we charge

- \$50 per person for all airline seat reservations and baggage charges plus any airline fees.
- \$100 per person for all Tourist visa processing plus the cost for the visa fee.
- \$75 per person to reissue any travel documents lost in the mail.
- \$100 per person to process insurance claims when travel insurance has not been purchased from this office.
